
WHAT WE HAVE DONE

In case you missed it -

Saturday, April 9, 2005, the Oklahoma Chapter of SGI-USA completed a three year program to plant 100 trees along the Memorial Trail, a bicycle and pedestrian Path which is part of the OKC Metrotrail System. The trial runs along the eastern boundary of Del City adjacent to Tinker AFB, along Sooner Rd., from SE 29th St, South to SE 44th. The city began building the trail in September 2001 East of the area where more than 550 homes were destroyed by the May 3, 1999 tornado. SGI-USA is a Buddhist organization whose aim it is to foster relationships with local communities by utilizing this and similar events to establish and improve communication skills, and to develop and sustain relationships within the community based on trust and respect. The group planted 34 trees in the final annual installment of the program, with participation of group members from Del City, Oklahoma City, Midwest City, Tulsa, Lawton, McAlester, Stillwater, Norman and Yukon. They were supported in their efforts by members of the Del City Public Works Department. Several varieties of trees suitable to the location and climate have been planted, including Yoshino Cherry, Green Vase Zelkrova, Burr Oak, Eastern Redbud, Lace Bark Elm, and Bald Cypress. Of the 66 trees planted in 2003 and 2004, about 10 have not survived and the City is working with other groups to replace them.
