

The 1st occurred at 4820 Michael Drive at 10:08pm on Saturday, Nov. 11th. The elderly victims arrived home where they were approached in their open garage by a B/M suspect, early 20s, approx. 5'8" wearing tan pants and a light tshirt, with a small mustache. The suspect robbed the couple at gunpoint using a silver automatic handgun. The suspect fled the area.

The 2nd occurred at 4704 Judy Drive at around 1:30pm on Tuesday, Nov. 15th. Two elderly victims arrived home. The female victim was attempting to unload a microwave from her vehicle in the open garage where she was

It takes an entire community working together to help ensure student success. With your help Mid-Del Schools has been able to improve our school sites over the years. Thank you for your support of Mid-Del Schools.

"Where Children Come First."

Why is the bond election needed?

Up-to-date equipment and safe, well maintained facilities are essential to ensure Mid-Del's students the best possible education. The 2005 school bond election is being held so voters may approve bonds to pay for necessary equipment and for school improvements including construction, remodeling and repair.

Who will benefit?

All students will benefit. See the list of projects and improvements to be accomplished at each individual school site as listed below.

How will the bond funds be spent?

Bond funds—100% of the \$11,125,000 will be used for improving school sites, constructing, repairing, remodeling and equipping school buildings, and acquiring school furniture, fixtures and equipment.

What will it cost me?

The annual cost is expected to be less than \$30 on a home valued at \$100,000.

Where and when may I vote?

If you are a registered voter who lives in the Mid-Del School District, you may vote at your regular precinct polling place between 7 a.m. and 7 p.m. on December 13, 2005. Passage of a school bond issue requires approval of 60% of the voters.

The suspect, 20 to 25 yoa was described as a B/M, very slender build, approx. 135 lbs, wearing a gray hoodie with "Piedmont" on the front of the jacket and wearing gray sweatpants. The suspect robbed the female victim in the garage and then forced her into the home. The suspect then assaulted the male victim by hitting the victim with the gun as he robbed the male victim of cash also. The male victim suffered a broken nose and severe bruising from the assault.

The 3rd occurred at Cedar Hills Apartment Complex located at 4625 Tinker Diagonal on Thursday, Nov 17 at approx. 1:30pm. An elderly male victim was confronted at the door by a B/M early 20s, 5'05" to 5'08". The suspect had a light complexion, slender build, and was approx. 130 to 140 lbs. The suspect struck the victim on the back of the head with a handgun. No known direction of travel or vehicle info.

In all 3 cases the victims had returned home shortly before the Robbery took place indicating the suspect may be cruising the area watching for elderly people that appear to be on their way home. The suspect then follows the victims to their residence where the robberies take place. It is important that anyone, especially our elderly citizens, be constantly aware of their surroundings as they go to and from their homes. They should be cognizant of the possibility that someone may be following them with the intent to victimize them. Police officials are working with Neighborhood Watch Groups to increase and enhance security in all areas of Del City. Anyone with information on these crimes can call the Del City Police Department at 677-2443.

SCAM Prevention

Jury Duty Scam Leads to Identity Theft:

Here's a new twist scammers are using to commit identity theft. Here's how it works: The scammer calls claiming to work for the local court and claims you've failed to report for jury duty. He tells you that a warrant has been issued for your arrest.

The victim will often rightly claim they never received the jury duty notification. The scammer then asks the victim for confidential information for "verification" purposes.

Specifically, the scammer asks for the victim's Social Security number, birth date, and sometimes even for credit card numbers and

other private information exactly what is the scammer needs to commit identity theft.

So far, this jury duty scam has been reported in Michigan, Ohio, Texas, Arizona, Illinois, Pennsylvania, Minnesota, Oregon, and Washington state It's easy to see why this works. The victim is clearly caught off guard, and is understandably upset at the prospect of a warrant being issued for his or her arrest. So, the victim is much less likely to be vigilant about protecting their confidential information.

In reality, court workers will never call you to ask

for social security numbers and other private information. In fact, most courts follow up via snail mail and rarely, if ever, call prospective jurors. **Action:** Never give out your social security number, credit card numbers or other personal confidential information when vou **receive** a telephone call. The jury duty scam is just one of the latest in a series of scams to steal your identity, and personal information. Protecting yourself is simple: Never give out this information when you receive a phone call.
