A reader sends this Crime Prevention Tip:

SCAMS MISREPRESENTING THE FINANCIAL CRIMES ENFORCEMENT NETWORK OF THE U.S. DEPARTMENT OF THE TREASURY Perpetrators commonly use various government agencies or officials to legitimize their scams. Most recently, the Internet Crime Complaint Center (IC3) has received several complaints which fraudulently represent the Financial Crimes Enforcement Network of the U.S. Department of the Treasury. Victims reported they received an e-mail claiming to be from the U.S. Department of the Treasury stating their lost funds, which were stolen and diverted to a foreign account registered in their name, have been recovered. The e-mail advised to cease all money transactions, especially overseas, and to respond to the e-mail so the lost

funds could be returned. The e-mail further stated the U.S. government is making adequate arrangements to ensure outstanding beneficiaries receive their funds. The e-mail is signed by James H. Freis, Deputy Director of the Financial Crimes Enforcement Network, and requires victims to provide personally identifiable information that could potentially result in identity theft. The U.S. Department of the Treasury posted a scam alert on their website on April 13, 2011, stating they do not send unsolicited requests and do not seek personal or financial information from members of the public by e-mail and recommending that recipients not respond to such messages. The alert further provides links for victims to report solicitations claiming to be from the U.S. Treasury.

Stormwater Quality

The City Del City is under a Department Of Environmental Quality permit for protection of stormwater. The permit is part of the 1972 Clean Water Act that also regulates municipal wastewater plants and industrial discharges.

Runoff is rain or melted snow the picks up and carries away natural and human-made pollutants, finally depositing them in streams, rivers, lakes and even underground sources of drinking water.

The pollutants include but are not limited to:

- Excess fertilizer, herbicides, and insecticides.
- Oil, grease, and toxic chemicals from runoff.

Sediment from improperly managed construction sites and erosion both natural and created by additional water being directed to a stream or river.

The Del City Public Works will recycle used oil. Please call 671-2874.

Please remember that the city of Del City has made arrangements for residents to dispose of hazardous household waste (paint, cleaners, herbicides etc) at no charge to the resident by contacting Midwest City at 739-1352
