

Dear Del City Citizens:

In April and May of 2015, the Cities of Del City and Midwest City adopted Resolutions opposing the introduction of treated wastewater from the Norman Wastewater Facility into Lake Thunderbird.

Lake Thunderbird is the primary source of drinking water for Del City and Midwest City and is designated a "Sensitive Water Supply," defined in the Oklahoma Water Quality Standards in Chapter 45, Subchapter 3(c) as follows, "It is recognized that certain public and private water supplies possess conditions that make them more susceptible to pollution events and require additional protection. These sensitive water supplies shall be maintained and protected." The United States Environmental Protection Agency's "National Primary Drinking Water Regulations" can be found at water.epa.gov/drink/contaminants/.

Attached is a copy of Resolution 05-04-15A adopted by the City of Del City. The Central Oklahoma Master Conservancy District (COMCD) has set up an email address at admin@comcd.net where you can express your opinion on this issue. I would encourage you to participate in the process.
