## IRS Scams On the Rise

#### How Not To be a Target

I came home the other day and saw a blinking message on my answering machine. I hit play and here's what it said:

"This automated message should be considered as a final notice from IRS, Internal Revenue Service. The reason of this call is to inform you that IRS is filing lawsuit against you. To give more information about this case file, please immediately call on (xxx) xxx-xxxx, I repeat (xxx)xxx-xxxx. Thank you."

This call is a scam. The IRS will never telephone you unsolicited. Do not call the number back. Note that the IRS handles most correspondence by mail.

Unfortunately, IRS scams are commonplace. Crooks target everyone, but tend to prey on vulnerable people. Scammers will phish for information and/or demand payments, and even threaten harm.

Nowadays, you need to be both street and home wise. Thieves are becoming more sophisticated, and folks nationwide are falling for these cons. Though incidents tend to rise during tax season, when people worry about owing money, they may occur all year around.

Sometimes the callers appear to be legitimate. They may have already obtained some personally identifying information about you. If there's any doubt, it's better to err on the side of caution and not provide any information to the caller.

Do not trust the caller identification on your phone. Calls from overseas have the capability of pretending to be from someplace within the USA. People may also be targeted by email. Email scams often look real, using the fake look-alike IRS logos. It's important to note that the IRS will never contact you by email.

Just remember, always protect your identity. To reduce your risk of becoming a victim, do not share personal information over the phone or via email.

Editors note: I have caller ID and I have received phone calls with my name and phone number showing, it's not possible for me to call myself on my home phone, and why would I anyway. BEWARE and re-read this column, you don't have to give out personal information ...

## There are things you can do to prevent being a target of a scammer:

- 1. Screen calls and don't answer unknown numbers.
- **2.** Do not return a call if you suspect it's a scam.
- **3.** Refuse to engage with a scammer by simply hanging up.
- **4.** Block numbers which are known to be illegitimate.
- 5. Never give out your credit or debit card numbers over the phone. Never give out PIN, bank or social security numbers or any other personally identifying information. Never send out any money.
- 6. If uncertain about the caller, hang up without giving them any information. Call the IRS at 800-829-1040 to determine if the caller is legitimate, or you may telephone your trusted accountant for advice. DO NOT CALL ANY NUM-BERS THE SCAMMER GIVES YOU.
- **7.** Stay updated on the news to be aware of the latest scams.
- Report scam calls to the Treasury Inspector General for Tax Administration (TIGTA) at www.tigta.gov.
- **9.** If you suffered a loss due to a scammer, or feel threatened, report the situation to the police.

# **Sales Tax Election September 8, 2015**

## **Keep Del City Moving Forward**

On September 8, 2015, city residents are being asked to approve a 1/2 cent sales tax increase. This is the first permanent sales tax increase requested of the citizens of this community in over 30 years. This should not be confused with the 1 ½ sales tax that is voted on in 5 year increments. Our current sales tax rate is 3 1/2 cent, but with this increase we would go to 4 cents. If you shop in Oklahoma City, Midwest City, Moore etc, you are already paying that rate or higher.

The purpose of this increase is for business development and neighborhood enhancement. Currently, if we enter into an agreement with a business to locate here, we have to utilize existing monies which takes away from other city needs. The goal is to have earmarked monies on hand specifically for such business transactions so we can stop the drain on our general revenue fund. The location of a new business in our city increases revenues available to meet the needs and enhance the quality of life in our community and brings jobs to our community.

For example the redevelopment at Del Crest Shopping Center and the new development at I-40 and Sooner Rd.





In addition, code enforcement and neighborhood revitalization take away existing monies from other necessities. In different sections of the city, neighborhoods are in decline and these neighborhoods and absentee property owners need further attention if we are to stop this decline. So far we have spent over \$60,000 dollars on code enforcement alone just cutting the grass on property that is abandoned, hauling off garbage and securing abandoned structures. This expenditure has only allowed us to keep current but not advance revitalization such as purchase and rehab of existing properties.

This is an example of some of the code enforcement issues that challenges the city.





By approving this  $\frac{1}{2}$  cent, paid by everyone who shops here, regardless of where they live, we can free up nearly \$500,000 towards other needs of the city as well as providing economic development seed money and revitalization money for our neighborhoods.

Please consider this proposal and lets keep Del City moving forward
