I-40 narrows at Sunnylane Rd. beginning Tuesday through 2023

Eastbound I-40 will be narrowed to two lanes between Sunnylane Rd. (mm 155A) and Hudiburg Dr. (mm 156A) from 7 a.m. to 6 p.m. Tuesday and continuing daily as work begins on multiple bridge reconstructions at Crutcho Creek, S.E. 15th St. and Sooner Rd. Motorists can expect intermittent ramp closures throughout from 7 a.m. Tuesday to 6 a.m. Wednesday. Other traffic impacts include:

- Eastbound I-40 will be narrowed to one lane from 8 p.m. Tuesday to 6 a.m. Wednesday and continuing nightly through Friday;
- The eastbound I-40 Service Rd. will be narrowed to one lane between S.E. 15th St. and Hudiburg Dr. from 7 a.m. Tuesday through spring 2021; Sooner Rd. will narrow to one lane in each direction under I-40 between the service roads at 7 a.m. Tuesday and continuing through spring 2021, including a short-term full closure by mid-September. Motorists may use the service roads
- Motorists are advised to locate an alternate route such as I-240 and US-62/N.E. 23rd St. or plan extra travel time and be prepared for delays in the area.
