You know the old saying "The best laid plans . . ", so I had DCFD Chief Zion Williams all set to speak at the July 8th DANWA Meeting right up till the morning of. Chief Williams calls me and explains that he has a family issue that is going to require his attention for the next couple of days. Well there you go, Fortunately we were able to reschedule for October 14, which just happens to be in fire prevention month.

Another yesteryear saying is "Things happen for a reason". Less than an hour before I get the call from Chief Williams, I receive a call from Mayor Floyd Eason stating that he would appreciate some time at our meeting to go over an important development regarding the proposed relocation of the Oklahoma County Detention to 1901 E. Grand. Rep Andy Fugate, Mayor Floyd Eason, and Mid-Del School Board Member Gina Standridge are co-sponsoring "a petition to impanel a Grand Jury to investigate the actions of Oklahoma County Commissioner - District 3. Myles Davidson." Details of the petition are attached to the signature page and are available at Del City City Hall, Del City Chamber of Commerce, Del City Community Center,

P J's Flowers, or several other businesses and individuals. You must be a registered Oklahoma County Voter to sign the petition.

Speaking of Rep Andy Fugate, he has agreed to be our guest speaker at the DANWA meeting on September 9th. Rep. Fugate has been a frequent guest and has delivered several informative talks as to the goings on at the Oklahoma State Capitol.

Back on June 30th, as I was patrolling our area, I decided to count the number of homes that were displaying the American Flag, regardless of size. I'm not saying that I didn't miss one or two, but here are some of my findings: all 3 banks, 1 church, only 2 businesses, and the Masonic Lodge, had a Flag. Sadly, out of our 1500 plus homes only 80 had a Flag flying. I failed to note the number of empty flag poles, but there were many. As a veteran, the saddest part was the number of torn, tattered or discolored American Flags that had been seemingly abandoned. How shameful and disrespectful. Catch phrase "UNWANTED JAIL" near Del City and "CORRUPTION OF A COUNTY COMMISIONER"

The Del Aire Neighborhood Watch Association is attempting to help the City of Del City's efforts to right a wrong with proof of WILLFUL MALADMINISTRATION, UNETHICAL AND WRONGFUL USE OF HIS AUTHORITY AS A PUBLIC OFFICIAL, CORRUPTION IN OFFICE, NO REGARD OF WHAT THE CONSTITUENTS OF OKLAHOMA COUNTY DO NOT DESIRE, ELECTION CAMPAIGN ETHICS, AND FAILURE TO COMPLY WITH THE OKLAHOMA OPEN RECORDS ACT.

Find someone who has a petition and sign as quickly as possible as it will have a direct effect on the City of Del City residents east of South Bryant Ave. The petition contains in part:

PETITION TO IMPANEL A GRAND JURY to investigate the District 3 Oklahoma County Commissioner for wrong doings to include the purchase of real property at or around the area of 1901 East Grand Boulevard, Oklahoma City from the personal friend, acquaintance and campaign donor of said commissioner utilizing Oklahoma County public Funds, agreeing and accepting a paid contractor for Oklahoma County to host a campaign fundraiser on their campus for the commissioner's election, failing to file and disclose campaign donation reports to the Oklahoma Ethics Commission in excess of one (1) year, failing to comply with the Oklahoma Open Records Act.

Throughout the process of selecting an appropriate site for the potential Oklahoma County Detention Center, the commissioner has been advocating for the site at or around 1901 East Grand Boulevard, Oklahoma City which is owned by his personal friend of 30+ years, Patrick Garrett Junior. Mr. Garrett is also an active donor to the commissioners campaign.

The potential site was purchased by Mr. Garrett in 2017 for an amount of \$ 1.4 million and has been placed under a provisional contract to Oklahoma County for \$5.4 million without any noticeable improvements or enhancements. The Commissioner is continuing to fundraise for his 2022 Campaign and agreed for an

Oklahoma County paid contractor, FlintCo, to host a fundraiser on their campus in March 2024. It was not until the news media reported this inappropriate action that the commissioner moved the location of the event.

The commissioner was negligent in his ethical duties to disclose, report, and file all campaign contributions to his 2022 Campaign [or any future campaigns] with the Oklahoma Ethics Commission since January 2023.

The Commissioner failed to comply with the Oklahoma Open Records Act when requested by an Oklahoma County resident, in writing, to reveal certain documents and electronic communications regarding certain business dealings between the commissioner and various named individuals concerning the 1901 East Grand property and the potential "land swap" for Crooked Oak School District.

Based on the foregoing, the commissioner has shown little regard for the moral and ethical integrity of his office as Oklahoma County Commissioner and developed a culture of mistrust between the residents of Oklahoma County and the Oklahoma County Board of Commissioners as well as a general lack of accountability and transparency which leads many to believe there is corruption of his public office.

The Applicants petition for the convening of a grand jury to investigate matters alleged as they establish grounds of Corruption in Office and Willful Maladministration.

Please find a petition and sign as quickly as possible before the second week in August. Thank you for your interest in helping Del City battle Goliath.
