### From the DANWA President:

Dear Friends and Neighbors

Back on September 25th, DANWA held our annual appreciation dinner at the Golden Corral. In August, our By-Laws Committee met and spent several hours going over the DANWA By-Laws. At our September General Meeting, Chairman Joe Satterwhite presented a list of suggested changes to those in attendance. A summation of that list is presented in this newsletter. Please look at these proposed changes very carefully. Some of the changes are for clarity and/or clerical reasons, while others could affect the future actions of DANWA. At our October 13th meeting we will be discussing and then voting on these proposed changes.

Over the course of the spring and summer Del City has been working on refurbishing that portion of the Huey Long Community Center that was the old library. Most of the work has been completed, now the question is what are we going to do with that space. While it has long been the consensus that it was to be used as a Senior Center other uses are being explored; such as family events and educational programs / classes for youth. Assistant City Manager, Kellie Willbanks and Del City staff, have been investigating various organizations such as the YMCA, OSU extension, Atwell Wellness, Oklahoma County Sheriff Dept. and others that can bring different ideas to the table. I have asked Mrs. Willbanks to join us on October 13th to give us an overview of where we are with the facility. As usual, there will be a Q & A part of the presentation, but because of time restraints that evening, I will ask that questions and concerns be about the subject at hand, the Community Center.

In the listing below for the DANWA Bylaws the notations of **strikethrough** is followed by **BOLD NEW IN-FORMATION** (better known as the changes).

If you are interested in finding out more or concerned about any of the changes, please come to the next meeting.

The following are proposed changes to the Del Aire Neighborhood Watch Association Bylaws to be voted on at October's General Meeting:

Article 1: Section 2: Excluding any and all apartment complexes and trailer parks gated communities, including residents thereof.

Article 2: Section 6: The Association shall be promoted through neighborhood meetings directed toward residents of the area outlined in Article 1, Section # 2, and shall be governed and qualified by the basic policies set forth in Article # 2, Section ¥ 5.

Article 3: Section 6: c): Tax ID number and all tax records/receipts received during the term of the Association. will be kept for the term of the association. All tax records/receipts shall be kept for a minimum of seven (7) years.

Article 3: Section 6: Added "h) Current and last year's membership applications will be kept for one year."

Article 4: Section 1: **Yearly** membership dues in the Association shall be twelve dollars (\$12.00) fifteen dollars (\$15.00) per household. per year. Dues shall be payable on or before March 1<sup>st</sup>. Dues for members joining after the beginning of the fiscal year shall be on a prorated basis.

Article 6: Section 6: No substantial part of the activities of the Association or its officers shall be the carrying on of propaganda or otherwise attempt to influence legislation, and the Association or its officers **acting in their official DANWA capacity** shall not participate in or intervene in (including, but not limited to, the publishing or distribution of statements) and political campaign on behalf of or in the opposition to any candidate for public office.

Article 9: Section 3: The chairperson of the Bylaws Committee shall be responsible for keeping a computer diskette of the bylaws the bylaws on current digital storage, and a back-up copy shall be given to the Secretary.

Article 10: Section 1: The President, Treasurer and Patrol Captain shall inventory and prepare a list of all Association property on an annual basis. The inventory list shall be updated as changes occur. Both These officers shall maintain a copy of the current and prior years' inventory in their permanent file.
